

## **Luxury Shell Scheme Specification Sheet 2025**

### **Shell Build**

- Standard Height of the stand is 2480mm.
  - All stand dressing items/graphics/exhibits must be no higher than 2480mm. Please be aware if you have a perimeter stand on Level 1 then the height of the stand will be reduced, if you are unsure if your stand is affected then please contact ILTM Operations.
- Grey carpet
- Fascia displaying company name
  - The company name printed onto the name board is the name recorded in your Exhibitor Portal. If you have registered sharers on your stand, their company name will not be included.
  - Should you desire a different company name on the name board please contact the <u>Operations</u>
    <u>Team</u>. Any name change request after <u>10 November 2025</u> and any alterations made onsite will be subject to a fee.
  - o We do not allow exhibitors to personalise their fascia boards with graphics.

# **Electrics & Lighting**

You will receive the following per 9sqm of stand space:-

- 1x 500w twin flush universal socket
- 3 x spotlights on track.

If you wish to order additional electrics or lighting, please order these with Full Circle directly.

You will need to specify using a grid the correct positioning for lights and sockets - should the grid not be submitted; the items will be positioned at the discretion of the official electrical contractor and charges may be levied for onsite changes.

The power to all stands will be switched off 30 minutes after the close of the show each day. Please also remember to order a 24-hour supply for the open period if required.

Basic leading guidelines for socket outlets:

500 watt socket PC Computers, TV's, videos, spotlights to 500w & refrigerators

1000 watt socket Domestic filter coffee machines & lighting up to 1000w

2000 watt socket Kettles\* & machinery up to 2000w

3000 watt socket Hired coffee machines, machinery 2000w - 3000w

Please also be aware that all stands now need to have an electrical box. The dimensions of these boxes are 450mm x 300mm x 250mm (d). We will always look to locate these boxes in any void space, within a store area or from above the stand if possible.

### **Safety Questionnaire**

It is compulsory for all exhibitors complete a Safety Questionnaire when exhibiting at ILTM Cannes. The form is split into three sections:

Part 1 – Your company information

Part 2 – This is you signing to confirm that any electrics you plug into the socket/s provided are in good condition.

Part 3 – The venue has strict regulations regarding the materials used to decorate your stand e.g. graphics and fabrics. All materials must conform to French Fire rating, EN13501-1 and you will need to submit supporting documentation if you wish to use these materials.

To help assist with this and avoid any issues onsite we recommend that you contact the official <u>ILTM Signage</u> <u>contractors</u>, who will be able to supply graphics on your stand that conform to the venue's regulations.

The deadline for the submission of the Safety Questionnaire is **07 October 2025.**
